In addition, the OfficeMax Grand & Toy warranty protects you from any concerns you may have about manufacturer's warranty disclaimers. Every OfficeMax cartridge comes with a comprehensive warranty which provides replacement of the cartridge if it fails to work upon installation and even covers the cost of repair to the laser printer in the unlikely event that a defective compatible cartridge caused damage. OfficeMax cartridges have been manufactured under stringent quality control standards to assure performance that equals or exceeds the original equipment.

OfficeMax Grand & Toy warrants each compatible laser cartridge sold to be free of defects in both materials and workmanship under normal use and service for a period of one year from the original date of purchase. This warranty does not apply to cartridges which have been altered, damaged, improperly stored or installed, or subjected to abuse or abnormal operation. In event this cartridge fails during the warranty period, repackage the cartridge in its original packaging container, together with a brief description of the problem and a sample page of the print defect and return it to the dealer from whom you purchased it. OfficeMax Grand & Toy will at its option, subject to reasonable verification of the defect, replace the defect cartridge or refund the full purchase price paid for the cartridge. Further, in the event that any cartridge found to be defective causes damage to any compatible laser printer from which the cartridge was designed for use, OfficeMax will reimburse you for the cost of repairs required to correct such printer damage. Reimbursement of such cost is conditioned upon your providing (1) satisfactory evidence that the damage occurred during the warranty period, (2) satisfactory evidence that the cartridge was the actual cause of the damage, (3) a copy of the service report showing the name and address of the company performing the repair, (4) the original itemized invoice for the repairs performed, and (5) the signed statement of the company performing the repairs either on the service report or separately on the company's letterhead, stating that the damage to the printer was caused by the cartridge.
